

Title: Resolution to Improve Membership of UW-System President Search Committee

*Whereas,* the UW-System President search committee is only made up of Regents, Chancellors, and one Provost. This means that there is a lack of representation of students and faculty who are also impacted by this decision.

*Whereas,* there is no representation for University Staff, University Faculty, and University Academic Staff on the committee;

Whereas, the lack of diverse membership from different UW-System shareholder groups such as students, faculty, and staff does not adequately represent the UW-System as a whole;

Whereas, the only student representation is Student Regent Torrey Tiedman;

Whereas, having the student voice be made up of one Regent, does not adequately represent the students within the UW-System.

**Whereas**, in 2004 when they chose the search committee to replace UW-System President Katherine C. Lyall, there was one student on the search committee;

**Whereas**, in 2013 when they chose the search committee to replace UW-System President Kevin P. Reilly, there was four faculty members and one student on the search committee;

**Whereas**, this decision impacts 170,000 students, and 39,000 faculty and staff within the UW-System;

**Whereas**, 36.09(5) gives power to students to "organize themselves in a manner they determine and to select their representatives to participate in institutional governance";

*Be it therefore resolved*, we wish that the search committee members be reconsidered so that we can add at least three faculty and staff members, and at least three students.

*Be it therefore resolved,* we, the U.S.S. of the S.S.A. condemn the decision to have a lack of faculty, staff, and student representation on the UW-System President Search Committee.

**Be it therefore resolved,** this motion be distributed to Doug Mell, Interim Chancellor Patrick Guilfoile, UW- System Reps President Dyllan Griepentrog, UW-Campus Presidents, UW-System Board of Regents, Regent Vice President Michael M. Grebe, Chairs of UW-Stout Faculty and Staff Senate, Chippewa Herald, *Stoutonia*, Madison Times, Journal Sentinel (Milwaukee), Leader Telegram, State Senator Patty Schachtner, State Representative Rob Stafsholt, Governor Tony Evers, and Mark Pitsch.
