I am also going to try something different this year. Once FAC approves the Contingency 1 budget, I will prepare a report to present along with the budget spreadsheet. The goal is to create something with more digestible

information about our budget. I have also been researching the student governments of other UW Schools for insight on how they run their finance committees and plan on discussing any new ideas this yields with FAC. On top of everything else, I have begun brainstorming for SSA Audit Rules, so that we can audit student org spending and levy punishments for wrongdoing.

f. Director of Legislative Affairs – McConville

- i. This past week I think I accomplished a decent amount of things. I started the conversation with housing to set up a voter registration training. Due to my interest with the syllabus Ad Hoc Committee, I will now sit on that. I was asked to speak to faculty senate about the issue so I will be preparing for that in the next two weeks. We hopefully finished the Bylaw and Constitution edits this week. I also checked in with a few senators on what they are doing to make sure they get the assistance they need if so. Getting ready for Senator Schachtner's visit. Finally, I spoke and attended the State Treasures visit and talked to her personally. This visit got me thinking about starting to plan the Lobbying trip.

g. Director of Diversity and Inclusivity – Beaulieu

- i. This past week I did several things. I went to the Blanket Exercise at the First Congregational Church. This was a 3 hour demonstration put on by members of the Ho-Chunk tribe. This demonstration was

designed to educate individuals about the history of colonization of Indigenous individuals in America. I should be receiving a digital version of what was discussed soon and can share it with anyone who would like to see it. In addition to attending the Blanket Exercise I created and presented an open forum to the senate about my position, the Diversity & Inclusivity Council, and I gave a brief overview of the diversity initiatives for the year. I finished my bylaw edits and I did some emailing and working on paperwork for a potential speaker collaboration in the Spring.
