

Title: Resolution of Support of Wisconsin State Senate Bill 479 and Assembly Bill 440

Whereas, the Wisconsin State Senate Bill 479 (SB479) and Wisconsin State Assembly Bill 440 (AB440) "makes changes to areas of the law to prohibit discrimination based on a person's hairstyle, including a "protective hairstyle," which is defined in the bill to include braids, locs, and twists." (Wis. Legis. Assemb, 2020 & Wis. Legis. Senate, 2020);

Whereas, SB479 and AB440 "defines "race" to include traits historically associated with race, including hair texture and protective hairstyles" (Wis. Legis. Assemb. 2020 & Wis. Legis. Senate, 2020);

Whereas, according to a study done by JOY Collective "black women are 1.5x more likely to be sent home from the workplace because of their hair (2019 Dove CROWN Study)";

Whereas, black women are "83% more likely to report being judged more harshly on her looks than other women" (2019 Dove CROWN Study);

Whereas, prohibiting hair discrimination in the State of Wisconsin will ensure every student, worker and community member will be free from fear of discrimination;

Whereas, the passage of SB479 and AB440 will make certain the State of Wisconsin takes a step further into ensuring a safe and non-hostile work, school and community environment for all individuals regardless of race;

Be it therefore resolved, we, the U.S.S. of the S.S.A. support Wisconsin State Senate Bill 479 and Wisconsin Assembly Bill 440.
