X. New Business

a. 49.24.01 Support of the Creation of the Student Medical Leave Act

- i. This is support President Pechous in her lobbying efforts for the Student Medical Leave act that she created. This was passed at the UW-System Representatives meeting; however, I feel this is also important for our campus to support as well as we can make effective change for our student on this campus.

- Senator Brisbin
 - VP Serier and I went to the UW-System Reps at Riverfalls talk about her lobbying efforts for the Student Medical Leave Act. They don't allow for uninspected circumstances without severe consequences.

In the Fall or Spring if you have to leave at 3-4 week.

- Senator Brisbin reads two quotes from the attachment: ““In treatment programs, they tell you that recovery does not happen just by getting treatment. It is an all-hands-on-deck operation with your medicine, therapist, psychiatric doctor, family, and yourself. There are many parts to a recovery path than just one piece of the puzzle. Universities should understand that they play a part in that, too, since, again, campuses all over the nation are advocating more and more for mental health; therefore, if campuses, on the surface level are advocating for mental health, they must all-hands-on-deck support their students. An affected person’s recovery plan must include the university. In most cases, I believe, it would be actually detrimental to a student’s mental health if they dropped out of classes and isolated themselves from their community connections. “ – *Rosemary Pechous*

- “My story does not represent every student, and Student Medical Leave Act may not fit every circumstance that arises, but neither does Family Medical Leave Act. There are unique circumstances for every person and

situation. However, Student Medical Leave Act would be the first of its kind to protect students and move toward a culture that respects students. Students are held to such discriminating terms” – *Rosemary Pechous*

- Students’ lives are not set in 14-week blocks. We have real issues that arise, and while it would be convenient to deal with those issues over J-term or Summer break, it is unrealistic.
- Director Beaulieu
 - I just want to say I support this and take a stand on supporting the President of Riverfalls to have protection by the government, in regard to, the Student Medical Leave Act.
- Senator Schoenike
 - Also, advocate for federal and state wide change is ambition, and regardless if anything like this pass and our administration should get on it.
- Senator Franda
 - I support this and think it’s a good idea.
- Senator Kangas
 - I think this is good to bring this our attention and from personal experience I think this is

good for us.

- Vice President Serier
 - Rose went down to make her first run at this and we didn't get to hear from her and try to figure out where they're at in the process of lobbying.
- Advisor Witucki
 - Whether you pass this or not if you attach the person's narrative with it and work with the person narrative and a lot of grammatical that could be clean up. I would suggest if that is part of this and have them reedit that document to fix up some grammatical errors.
- Senator Brisbin
