XI. Reports

- a. President Canon
 - i. I had a few senator interviews. Had a good lunch with Advisor Witucki and VP Johnson, I job shadowed the Blue Devil Production Campus Marketing Director as the position is the inspiration for the Public Relations Specialist. Right afterwards I had an interview with a potential senator. Had a meeting with VC Lyons and

- c. Director of Communications Roberts
 - i. This past week I sent out emails about the carbon neutral resolution. I also hat the first visibility and outreach meeting. I worked on the minutes from last week. f. Director of Legislative Affairs – McConville

i. This past week mostly consisted of finishing the Bylaw edits, so they can hopefully get passed. This took an immense amount of work from President Canon, Vice President Johnson, Senator Briggs and Halbach, Senator Dumke decided to join us this last week and had valuable additions. I also sent out another reminder email to Representative Stafsholt, and sent a thank you to Senator Schachtner. I will be moving my attention to planning a lobbying trip, as this is something that has been put on my back burner due to Bylaws and the Constitution edits.

g. Director of Diversity and Inclusivity - Beaulieu

i. This past week I did several things. I finished watching the budget forum so I knew the status of our budget at UW-Stout. I continued working on getting events ready for diversity week and started thinking about what funding we need for diversity week. I also did lots of contacting individuals to try and get a speaker to campus. I currently am working to negotiate their price down, and I have started the contract. I also was contacted by Her Campus to

help with a event. Lastly I did my weekly tasks of going through my email, running my council, and uploading my minutes to connect.

h. Director of Sustainability - Nadeau

- i. Last week I held the Sustainability Council which was another meeting with great discussion. I also went to meetings for the Waste Reduction Work Group and Sustainability Steering Committee which I wrote reports on separately. Another meeting I went to was a meeting to discuss the details for the two segregated fees that I will be presenting on in November to the USS. I held a meeting for the Stout-Bus Group where we discussed the agenda topics for the meeting on October 29th with Dunn County Transit. Finally, I went to the Marketplace presentation meeting where I learned about the new housing page being developed by campus groups.
- i. Director of Information Technology Kangas
 - i. On Monday, I met with Sue Traxler to talk about incoming requests for STF in addition to the bylaws for SITC. I also attended SPG on Monday which does not have anything of importance to note. For the rest of the week, I worked on the SITC bylaws and sent a few emails to people around campus; I think we are pretty close to finalizing the first SITC bylaws which is exciting. On Friday, I went to the grand opening of the Commons and North Hall. The renovation completely changed the buildings and it looks beautiful. I am very excited to see how these

spaces are used in the years to come.

XII. Additional Reports

a. Shared Governance

- i. Sustainability Steering Committee- In this meeting we discussed the two sub-groups of the committee which are for implementing an alternative transportation incentive program and for working on an administrative procedure for renovation and new construction. We then had a lengthy discussion on how to market the sustainable aspects of stout not only for new students but also to other departments in order to encourage them to put more sustainable elements into their coursework. Finally, we ended on briefly talking about how we wanted to go about reviewing the Campus Sustainability Action Plan.
- iii. Waste Reduction Work- In this meeting we talked about getting numbers together for event recycling and compost bins that the green fee is interested in funding. We also talked about departments on campus can request less packaging materials in their deliveries in their purchasing orders. Another topic was the financials of Dunn County Solid Waste & Recycling which was interesting to hear. Finally, we learned that Morgan Gerk form DCSW&R is going to be attending our next meeting.
- iii. Meeting with CSTEMM Dean Charles Bomar-The primary purpose of the meeting was introductions however we also discussed the topic of evaluations and complaints. Currently, communication between

the student body and administration is very weak.

Many complaints do not reach the administration and students rarely fill out the instructor evaluations that get sent out for every course. Both of these are vital to maintaining the health of the campus. Our working goal is to increase the quantity and quality of student feedback. If you have any questions or suggestions, please come talk to me.

- iv. STEMM Council Meeting-First, there was a presentation on student athletes in STEMM. Studentathletes are very important for enrollment, especially for STEMM. Over half the athletes on campus are STEMM majors and those that are athletes have a high graduation rate. There are a bunch more statistics covered, see me for more. Purpose was to encourage increased collaboration between STEMM and athletics in both advisement and enrollment. Next was a series of course revisions and new additions. The highlights were a new minor, Environmental Health, in the works (based on current courses) and a major program revision in Industrial and Applied Mathematics (designed to increase enrollment, targeting international students). If you are interested, see me for details.
- v. Senate Academic Staff The chair talked about the potential chancellors visits coming up, and gave the option for all senators to go to the lunch if they so choose. I learned that there is also a chancellors search page that exists. Next they talked about

budget costs, which usually happens every week. Also an awareness for the formal complaint procedures. Someone on the chancellors search committee came to the meeting and discussed how it is going, she gave a lot of good information that she could at that time. She said it is going good, and the search is very inclusive. Regent Plante will be coming back to get more input from people. Finally one key quote I took away from the meeting was that the chair pointed out that if senators are not educated on the motion they are voting on they should not be voting, they should be abstaining. Something we should also take note of at senate.
